To each of you my personal wishes for a very Merry Christmas and a blessed and peaceful New Year!

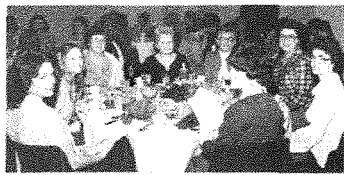

FOR THE EYES AND EARS OF MCSD . . . As you know, effective January 1, 1979, we will be adding Vision and Hearing coverage to our Blue Cross-Blue Shield Medical, Dental and Prescription Drug Program.

Shortly after January 1, you will be receiving summaries of each new program which will include both benefit information, as well as details on claim processing.

So that you will have some advance information regarding the new coverage, a general description of each plan follows:

VISION PROGRAM

1. Covered Expenses:

- (a) Eye Exam — Usual and customary expenses will be paid for a vision examination by an ophthalmologist or optometrist.
- (b) Lenses — Usual and customary expenses will be paid for single vision, bifocal or trifocal clear lenses.
- (c) Frames — If you obtain your frames from a Participating Provider (a listing of Participating Providers will be available by January 1), you may make a selection from a display that will be shown you, and there will be no out-of-pocket expense to you other than any Co-Payment as described below. However, if your selection at the Participating Provider is not from such display, or if you obtain your frames from a Nonparticipating Provider, \$15.00 is the maximum amount that will be considered a Covered Expense.

2. Co-Payments you will be required to pay

For each insured individual, there is a \$5.00 Co-Payment applicable during any period of 12 consecutive months for a vision examination, and a \$7.50 Co-Payment applicable to the combined Covered Expenses incurred during any period of 12 consecutive months for lenses and frames. The total Co-Payment for each insured individual, during any period of 12 consecutive months, will not exceed \$12.50.

HEARING PROGRAM

1. Covered Expenses

- (a) Audiometric Exam — Usual and customary expenses will be paid for an Audiometric Examination performed by a physician or audiologist.
- (b) Hearing Aid Evaluation Test — Up to \$40.00 will be paid for a Hearing Aid Evaluation Test performed by an otologist, an otolaryngologist, or an audiologist.
- (c) Hearing Aids — Usual and customary expenses will be paid for in the ear, behind the ear or on the body types of hearing aids.

2. Co-Payments you will be requested to pay.

There are no Co-Payments with the Hearing Benefit Program.
