**EMPLOYEES OPT . . .** Salaried employees enrolled in the Profit Sharing Plan prior to the merger and all hourly employees enrolled before and after the merger, recently exercised their option as to how monies in their accounts are to be invested, effective the first of the year.

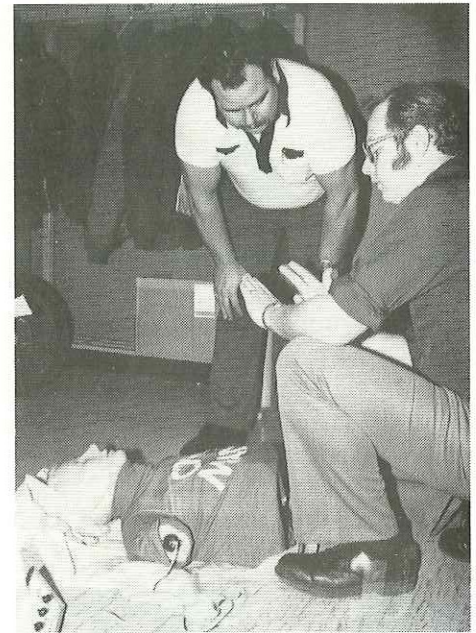
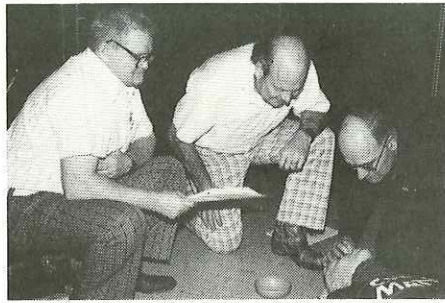
These employees could select one of the following two options: Fund A which has the objective of maintaining principal and earning a guaranteed rate of return. Investment instruments will consist principally of insurance contracts providing guaranteed rates of return, time deposits, certificates of deposits, and similar forms of investments.

Fund B is a "Balanced Fund" and will be invested and re-invested in such investments as common stocks, preferred stocks, bonds, notes, debentures, mortgages, certificates of deposit and annuity contracts.

Of the two funds, Fund A is the more conservative with preservation of principal as its main objective, while Fund B will generally be more sensitive to changes in financial market conditions and interest rates.

The employees will have the opportunity to change their individual investment election once each year during the month of September. The change, if any, would take effect January 1 of the following year.

**CPR INSTRUCTION HELD . . .** Co-ordinated by **Dale Bressler** (Assembly) and conducted by **George Smith** (Machine Shop) and **Jim Smith** (Foundry), instruction in lifesaving CPR (Cardio Pulmonary Resuscitation) was given last week at the R & D auditorium.
